Conditions Of Installation

1. The machinery supplied always remains the property of Rotolula Family Trust.
2. The site operator or person signing this agreement undertakes to insure the machinery whilst under their control and is personally responsible for the safe keeping of machinery/equipment.
3. The site operator or the person signing this agreement undertakes to clean and maintain the machinery/equipment whilst under their control in accordance with Rotolula Family Trust T/A Australia's Best Hogs Hot Dogs requirements and instructions. A \$45.00 cleaning surcharge/fee will be charged for any dirty/unclean machines/equipment. In addition, any damage to the machinery is the responsibility of the site operator or person signing this agreement and he/she will be liable for any charges related to any burnt out elements, broken glass, other damage or loss. This may or may not be as a result of deliberate misuse of the equipment. The site operator or person signing this agreement will ensure no employee or other person will alter, interfere with or modify the machinery/equipment and all persons using said machinery and equipment agrees to comply in accordance within NSW State and Australian Federal food handling and storage regulations. The site operator takes all responsibility for any incident involving the equipment and products supplied and have their own current and valid public liability insurance. Rotolula Family Trust T/A 'Australia's Best Hot Dogs' accepts no responsibility for any legal action taken by any person using our equipment or products and the site owner/operator accepts all liability.

ONLY PRODUCTS SUPPLIED BY ROTOLULA FAMILY TRUST ARE TO BE USED IN STEAMERS.

4. All stock remains the property of Rotolula Family Trust until payment is cleared in full. This agreement is for all and any of our supplied equipment and products.
5. Payment is to be made on agreed terms of **7 days / 14 days / COD** (circle one) & any amount outstanding past these terms may be passed to a third party for collection and such collection costs will be the responsibility of the site operator and/or the person signing this agreement.
6. Accounts must be paid in full upon termination of this agreement and the machinery -equipment must be returned immediately in a clean and serviceable condition.
7. Products supplied by Rotolula Family Trust are the only products to be used in conjunction with the supplied machinery or equipment. If the site operator does not order for more than 45 days from the last order an \$11.50 per week hire fee from the last order will apply.
8. The site operator or person signing this agreement is responsible for safe keeping of any Point of Sale (POS) promotional items. Any lost, stolen or damaged promotional items will incur a minimum \$65.00 fee. The site operator or person signing this agreement will be responsible for the cleanliness of any/all POS material. Lost or damaged 'A' Frames incur a \$195.00 fee.
9. By signing this agreement the site operator or their representative agrees to pay the full replacement cost of \$1650.00 per Hot Dog Steamer/Machine, \$890.00 per Double Decker attachment and \$65.00 per Drainage Kit for any lost, stolen or damaged equipment.
